REGULATIONS
on the procedure and organization of the annual competition
for the enlightenment award Znanie.Award – 2026

1. General provisions

1.1. Regulations on the procedure and organization of the annual Competition for the Enlightenment award Znanie.Award – 2026 (hereinafter referred to as the Regulations) define the procedure and order of organizing the annual Competition for the Enlightenment Award Znanie.Award in 2026-2027 awarded by the All-Russian Public-Government Enlightenment Organization Russian "Znanie" Society (hereinafter referred to as the Competition).

The designations of the Competition: Enlightenment award Znanie.Award and Enlightenment award "Znanie" are interchangeable.

1.2. The All-Russian Public-Government Enlightenment Organization Russian "Znanie" Society (hereinafter referred to as Russian "Znanie" Society, the Organizer, Znanie) poses as the Organizer of the Competition. 1.3. The official website of the Competition: <https://award.znanierussia.ru> (hereinafter referred to as the Website).

1.4. The e-mail address of the Organizer of the Competition: premiya@znanierussia.ru.

1.5. The official language of reference of the Competition is Russian.

1.6. Governmental, privately held or public organizations of any level that provides resources (information, technical, organizational, expert, etc.) and informational support are eligible to become Competition partners.

1.7. To achieve the purpose and fulfill the objectives of the Competition, the Organizer may engage third parties.

1.8. The Competition is conducted in order to contribute to achievement of the objectives of the Federal project "We are together (Education of harmoniously developed personality)" of the national project "Youth and Children". which is a structural component of the Russian Federation's state program "Federal Projects" under the Russian Federation's state program "Development of Education".

1.9. Expenditure related to the operations of the Competition is covered by earmarked funds (grants) in the form of a subsidy provided by the Federal Agency for Youth Affairs (Rosmolodyozh) to the Organizer of the Competition and / or other sources.

1.10. The results of the Competition are projected to achieve the following values of indicators for the provision of subsidies:

- number of online and offline presentations given by Speakers (experts, scientific and cultural figures, outstanding academics, athletes, pedagogues, teachers, educators, education leaders, experts and specialists in youth policy, public and government figures, ambassadors and representatives of the business community);

- coverage of listeners and readers of enlightening video, audio and textual content produced, events held (including forums, conferences, online and offline round table sessions) during the enlightenment activities of experts, scientific and cultural figures, outstanding academics, athletes, pedagogues, teachers, educators, education leaders, experts and specialists in youth policy, public and government figures, ambassadors and representatives of the business community.

1.11. Income received by individuals from the Organizer under these Regulations in the form of grants, awards, prizes, and/or gifts in monetary and/or non-monetary form, including payment for transportation and tour services, meals, accommodation, and other income (if received), shall not be subject to personal income tax in accordance with paragraph 6.3 of Article 217 of the Tax Code of the Russian Federation and Resolution of the Government of the Russian Federation No. 602 dated July 15, 2009.

2. Terms and definitions

2.1. The following terms and definitions are used during the Competition:

An "**Enlightener**" is a citizen of the Russian Federation from the age of 12 or a foreign citizen from the age of 18 who carries out educational activities with outstanding achievements in the professional field and / or possesses the necessary competencies;

An "**Enlightenment project**" is a product of creative activity or a set of activities and / or works aimed at enlightenment, as well as improving the scientific, educational and cultural background of citizens of the Russian Federation;

An "**Enlightenment company**" is a legal entity implementing a set of measures aimed at educating, as well as improving the scientific, educational and cultural background of citizens of the Russian Federation;

A "**Submitter**" is an individual who is registered on the Website and has submitted one or more applications for Applicants (Enlighteners, Enlightenment projects, Enlightenment companies);

An "**Applicant**" is an individual (an Enlightener), a legal entity (an Enlightenment company) or an Enlightenment project submitted by a Submitter in an application on the Website;

A "**Participant**" is an Applicant specified in the application form filled out by a Submitter and approved for evaluation by passing the Organizer's Preliminary evaluation;

A "**Preliminary evaluation**" is the Organizer's review procedure for completeness of the data filled out and compliance with the requirements of the present Regulations of the applications received for the Competition;

An "**Applicant for nomination**" is a Participant that passed the Qualifying stage of the Competition;

A "**Nominee**" is an Applicant for nomination that won the First stage of the Competition;

A "**Winner**" is a Nominee that won the Second stage of the Competition;

A "**Competition partner**" is a governmental, privately held or public organization of any level that provides resources (information, technical, organizational, expert, etc.) and other support for the events of the Competition;

The "**Expert commission**" is a group of experts comprised of representatives of the Competition partners or any other expert group responsible for the preliminary selection and evaluation of the Competition applications at the Qualifying stage of the Competition;

The "**Expert council**" is a group of experts representing government authorities and business figures responsible for evaluating applications at the First stage of the Competition;

A "**Lecturer-Enlightener**" is an individual who engages in public activities aimed at promoting reliable knowledge, popularizing science, culture, and socially significant ideas through lectures and public speaking, with the goal of enhancing the intellectual development of civil society;

The "**Jury panel**" is a group of experts responsible for evaluating the Nominees of the Competition at the Second stage of the Competition, comprised of outstanding representatives of science, art, business, sports, as well as government figures, leaders of industrial public associations and representatives of the Competition partners;

The "**Organizing Committee**" is a collegial body established by the Organizer to coordinate the preparation, conduct, and summarize the results of the Competition, authorized to resolve operational and procedural matters within the framework of these Regulations;

The "**Website**" is a web page containing information about the Competition and an application form for registration of Participants available at <https://award.znanierussia.ru>;

The "**Qualifying stage**" is a stage that includes the Organizer's Preliminary evaluation of applications, their evaluation by the Expert commission and drafting a list of Applicants for nomination;

The "**First stage**" is the Expert council's evaluation of applications from among the Applicants for nomination selected by the Expert commission at the Qualifying stage and drafting a shortlist of Nominees for the Competition;

The "**Second stage**" is the evaluation of projects, initiatives and enlightenment activities of the Nominees of the Competition (Winners of the First stage) by the Jury panel and the formation of a list of the Winners of the Competition;

The "**In-person defense**" is the procedure of defense of enlightenment projects and activities of companies and Nominees directly by the Nominees themselves or representatives of the Nominees (projects, companies), held in the form of a Speech before the Jury Panel. Nominees, accompanying individuals, Jury panel members, experts of the Competition, the distinguished Guests, the mass media and other individuals may attend the In-person defense.

The "**Award ceremony**" is the event honoring of the solemn awarding of the Winners of the Competition featuring the Culturally enlightening program

and the Creative program;

The "**Culturally enlightening program**" is an event within the framework of the Award ceremony that includes meeting, accreditation, and escorting for the Nominees and other participants of the event, as well as a series of creative performances, a reception, and other activities;

The "**Creative program**" is an event within the framework of the Award ceremony lasting upwards of 120 minutes with participation of Nominees and other participants of the Competition, featuring creative performances accompanied by audiovisual effects, as well as performances by artists, creative groups, Nominees and Speakers, announcement of the Winners of the Competition, presentation of the Competition awards and other activities;

The "**other participants**" are participants of the events held within the framework of the Competition (other than Nominees), including: individuals accompanying the Nominees, individuals accompanying the Participants (for medical reasons), individuals accompanying the minor participants, representatives of the Expert commission, the Expert council, and the Jury panel, representatives of the partners of the Competition, Guests (Distinguished Guests), Speakers, the best Enlighteners and Enlightenment projects as determined in accordance with Clause 8.15 of these Regulations, the Winner and Nominees of the Competitions held in the previous years, Volunteers, invited Artists, members of the press, and others;

The "**Guests**" (also "**Distinguished Guests**") are individuals invited by the Organizer to the events within the framework of the Competition, including the Award ceremony and the announcement of the Winners of the Competition, featuring representatives of state authorities, public associations, representatives of educational organizations, the scientific community, partnered organizations, members of the Expert commission, the Expert Council, the Jury panel, the Nominees and Winners of the Competitions held in the previous years and etc.;

A "**Speaker**" (a lecturer, expert, scientific and cultural figure, outstanding academic, athlete, public and (or) a governmental figure, and (or) a representative of the federal and regional business communities) is a person of proficient expertise in certain fields, addressing the audience regarding relevant enlightenment-related points;

A "**Speech**" is a means for the speaker to convey enlightenment-related points in offline / online / mixed (offline and online) formats to the audience. Speakers' presentations may be conducted individually (lecture, workshop, training, interview and other formats lasting upwards of 5 minutes), or in a group of Speakers (panel discussion, plenary session, debate and other formats lasting upwards of 30 minutes);

The "**MAX digital platform**" (hereinafter also referred to as "**MAX**") is a Russian multifunctional digital platform used to conduct public online voting as part of the Competition;

The "**Federal Council of the First**" is a voluntary self-governed body of the All-Russian Public-Government Movement of Children and Youth "Movement of the First" (89 participating children from all constituent entities of the Russian Federation delegated by decisions of the Council of the First's regional branches of the All-Russian Public-Government Movement of Children and Youth "Movement of the First").

3. The purpose and objectives of the Competition

3.1. The purpose of the Competition is to raise popularity and prestige of Enlighteners, popularize enlightenment and publicly recognize the achievements of aspiring young Russian figures aged 12 to 17 along with foreign enlightenment figures.

3.2. Objectives of the Competition:

3.2.1. Popularization of enlightenment activities within the territory of the Russian Federation and abroad.

3.2.2. Establishing and encouraging young and promising enlightenment figures and projects/initiatives along with assistance in their development via the support of the Russian "Znanie" Society.

3.2.3. Providing conditions for professional, personal and civic fulfillment to young people in Russia.

3.2.4. Establishing and encouraging enlightenment figures to objectively cover historical facts about the Russian Federation.

3.2.5. Establishing and encouraging enlightenment figures in order to have a positive impact on the development and strengthening of Russia's international relations.

3.2.6. Conducting a comprehensive multi-stage evaluation of Participants, Applicants for nomination and Nominees of the Competition, based on the use of complementary methods that allow rating the substantial qualities and competencies of Participants, Applicants for nomination and Nominees of the Competition.

3.3. The Competition is to be conducted pursuant to the principles of:

- publicity;
- impartiality;
- transparency.

4. The procedure and time frame of the Competition

4.1. The time frame of the Competition is determined by the Organizer and published on the Website. The time frame of the Competition includes the following stages:

4.1.1. Registration of Submitters of the Competition via the Website and collection of applications: April to September 2026.

4.1.2. The Qualifying stage: April to October 2026.

4.1.3. First stage: October to November 2026.

4.1.4. The Enlightenment program: October to November 2026.

4.1.5. The Second stage: November – December 2026.

4.1.6. Conducting online popular vote and voting of the Federal Council of the First: November 2026 to February 2027 (the specific dates of online popular vote shall be determined by the Organizer within the above-mentioned time frame and indicated on the Website)

4.1.7. Summarizing the results of the Competition, holding the Award ceremony for the Winners of the Competition: on or before March 31, 2027.

4.2. The Organizer reserves the right to commit changes and additions to the time frame of the conducting of the stages of the Competition. Notification of changes in the time frame of the conducting of the stages is made available via a public notice on the official Website of the Competition. Individual notification of the Participants

of the Competition regarding the changes in the time frame of the conducting of the stages is not provided.

5. Experts of the Competition

5.1. The Organizer establishes three expert groups to conduct the Competition:

- Expert commission (hereinafter referred to as the Commission);
- Expert council (hereinafter referred to as the Council);
- Jury panel (hereinafter referred to as the Jury).

5.1.1. The composition of the Commission (upwards of 300 people) features representatives of the Competition partners or any other expert community. The approval of the composition of the Commission is conducted via the protocol of the Organizing Committee. The composition of the Commission remains publicly undisclosed as to avoid any external pressure on the experts. The tasks of the Commission feature pre-selection, evaluation of applications of the Participants of the Competition and drafting of a list of Applicants for nomination of the Competition.

5.1.2. The composition of the Council (upwards of 200 people) features representatives of governmental agencies, non-profit organizations and / or business communities. The approval of the composition of the Council is conducted by the Organizing Committee and is formalized via the relevant protocol. The Council is responsible for evaluating the Applications submitted by contestants from among the Applicants for nomination. At the discretion of the Organizing Committee, the Council may be formed in accordance with the nominations of the Competition.

5.1.3. The composition of the Jury (upwards of 40 people) features outstanding representatives of science, art, business and sports fields, as well as government officials, heads of public industry associations and representatives of the Competition partners. The approval of the Jury is conducted via the protocol of the Organizing Committee. The tasks of the Jury feature determining the Winners of the Competition from among the Nominees of the Competition by evaluating projects / initiatives according to the conditions specified in the present Regulations.

5.2. The experts of the Commission, the Council and the Jury may not evaluate their own applications or applications of the Participants of the Competition affiliated with them (or organizations represented by them), including cases of them or their close relatives being employees or members of joint entities of such an organization, as well as in any other circumstances that give reason to believe them being a party personally, directly or indirectly interested in the results. In case of presence (occurrence) of these circumstances, the expert is to immediately notify the Competition Organizer.

6. The procedure for determining the Participants of the Competition

6.1. The Competition is held in the nominations specified in Appendix No. 1 to the present Regulations. Each nomination includes one or more categories. The Organizer reserves the right to establish additional nominations (and categories) during the Competition. The procedure for participating and selecting the winner in such nominations shall be approved by the Organizer and posted on the Website of the Competition within 30 days prior to the deadline for accepting applications for the Competition.

6.2. In accordance with the nominations of the Competition specified in Appendix No. 1 to the present Regulations with the exception of the "Young Enlightener" and "Foreign Enlightener" nominations, the following individuals may apply as Participants for the Competition:

6.2.1. Enlighteners – citizens of the Russian Federation who were upwards of 18 years old at the time of registration and possess outstanding achievements in the professional field and / or certain competencies.

6.2.2. Enlightenment projects – projects created and implemented in 2025 and / or 2026 and aimed at enlightenment and improving the scientific, educational and cultural background of the Russian citizens.

6.2.3. Enlightenment companies – legal entities implementing a set of activities or projects aimed at enlightenment and improving the scientific, educational and cultural background of the Russian citizens.

6.3. To be a Submitter an individual must be aged 18 or more.

6.4. It is required to complete online registration and fill out an application on the Website in order to register an Applicant for the Competition, in accordance with the timeframes stipulated in clause 4.1 of the present Regulations. A Submitter may fill out an application for themselves (an Enlightenment project or an Enlightenment company they represent) or for another Applicant (an Enlightener, an Enlightenment project or an Enlightenment company).

6.5. By registering on the Website, the Submitter confirms that they have read, accept and fully agree with the present Regulations, the Personal data processing policy for conducting the annual Competition for the Enlightenment Award Znanie.Award – 2026 (Appendix No. 3 to the present Regulations) and consent to the processing of personal data (for the official Website) (appendix No. 4 or appendix No. 5 to the present Regulations).

6.6. When filling out an application for an Applicant other than themselves (an Enlightener, an Enlightenment project or an Enlightenment company), a Submitter ensures that:

6.6.1. The applicant (an Enlightener, creators and / or copyright holders of an Enlightenment project, managers and / or representatives of an Enlightenment company) has agreed to enter the Competition.

6.6.2. The Applicant (an Enlightener, creators and / or copyright holders of an Enlightenment project, managers and / or representatives of an Enlightenment company) has read, accepts and fully agrees with the present Regulation, the Personal data processing policy for conducting the annual competition for the Enlightenment Award Znanie.Award – 2026 (Appendix No. 3 to the present Regulations) and consents to the processing of personal data of the Participant of the Competition (Appendix No. 6 to the present Regulations), consents to the processing of personal data of the Participant of the Competition authorized for dissemination (Appendix No. 7 to the present Regulations), consents to the use of photographs of the Participant of the Competition (Appendix No. 8 and / or No. 9 to the present Regulations).

6.7. The Submitter is to provide authenticated relevant information in the Website registration form. The provision of unauthenticated information in the form is the basis for disqualification of the Participant of the Competition. The Organizer reserves the right to request authentication of the data provided in the form by contacting the Submitter

or the Applicant. The Submitter assures that they will independently settle claims of third parties if such claims are made in relation to the information specified in the applications sent to the Competition.

6.8. Simultaneous submission of applications of the same Applicant (an Enlightener, an Enlightenment project) but with differing enlightenment activities for different nominations is permitted. Submitters who submit applications for Applicants may be involved by the Organizer on a paid basis.

6.9. An Applicant that became a Nominee or a Winner of the annual Competition for the Enlightenment Award Znanie.Award – 2025 with its Regulations approved by the orders of the Russian "Znanie" Society No. Pr-34/25 dated February 10, 2025 (as amended by Orders No. Pr-387/25 dated May 12, 2025, and No. Pr-55/26 dated February 25, 2026) may not participate in the Competition with the enlightenment activity submitted in the application for the annual Competition for the Enlightenment Award Znanie.Award – 2025.

6.10. The changing of the nomination for an application of a Participant by the Organizer depending on the recommendations from the Commission and / or the Council is permitted.

6.11. Applicants become Participants of the Competition by fulfilling the following conditions:

6.11.1. Completion of registration by the Submitter and submission of an application of an Applicant on the Website within the time frame specified in clause 4.1.1 of the present Regulations.

6.11.2. Provision of information on enlightenment activities and achievements of the Participant of the Competition within the time frame specified in clause 4.1 of the present Regulations.

6.11.3. The Participant's compliance with the requirements specified in clause **Ошибка!** **Источник** **ссылки** **не** **найден.** of the present Regulations.

6.11.4. The application successfully passing the Organizer's preliminary evaluation.

6.12. The Participants of the Competition (Enlighteners, creators and / or copyright holders of an Enlightenment project, managers and / or representatives of an Enlightenment company) are obliged to respect the rights of third parties with respect to the results of intellectual activity used in the materials submitted to the Organizer, in accordance with the current legislation of the Russian Federation, and assure that they will independently settle claims of third parties if such claims are made.

6.13. The Participants of the Competition grant the Organizer the right to publish the materials provided by these individuals to the Organizer on the Website as well as to use them in the following ways: playback, distribution, public display, public performance, broadcasting and cablecasting, putting in the public domain via publishing on the Internet and being made accessible for all countries for participation in the Competition.

7. The procedure for determining the Participants of the Competition in the nominations "Young Enlightener" and "Foreign Enlightener"

7.1. The following Applicants may participate in the "Young Enlightener" and "Foreign Enlightener" nominations of the Competition:

7.1.1. For the nomination "Young Enlightener" – citizens of the Russian Federation whose age ranges from 12 up to and including 17 years (at the time of submission of the application), students of an educational organization as well as those possessing achievements in enlightenment activities.

7.1.2. For the nomination "Foreign Enlightener" – foreign citizens whose age is upwards of 18 possessing outstanding achievements in the professional field and / or achievements in enlightenment activities.

7.2. To be a Submitter an individual must be aged 18 or more (upwards of 12 years of age for the nomination "Young Enlightener").

7.3. It is required to complete online registration and fill out an application on the Website in order to register an Applicant for the Competition, in accordance with the timeframes stipulated in clause 4.1.1. of the present Regulations. A Submitter may fill out an application for themselves (an Enlightenment project or an Enlightenment company they represent) or for another Applicant (an Enlightener, an Enlightenment project or an Enlightenment company).

7.4. By registering on the Website, the Submitter (parent and / or legal representative of a minor Applicant) confirms that they have read, accept and fully agree with the present Regulations, the Personal data processing policy for conducting the annual Competition for the Enlightenment Award Znanie.Award – 2026 (Appendix No. 3 to the present Regulations) and consent to the processing of personal data (for the official Website) (appendix No. 4 or appendix No. 5 to the present Regulations).

7.5. When filling out an application for an Applicant other than themselves with information taken from sources other than public ones, a Submitter ensures that:

7.5.1. The Applicant (including the parent and / or legal representative of a minor Applicant) has agreed to enter the Competition.

7.5.2. The Applicant (including the parent and / or legal representative of a minor Applicant) has read, accepts and fully agrees with the present Regulation, the Personal data processing policy for conducting the annual Competition for the Enlightenment Award Znanie.Award – 2026 (Appendix No. 3 to the present Regulations) and consents to the processing of personal data of the Participant of the Competition and / or legal representative (Appendix No. 6 to the present Regulations), consents to the processing of personal data of the Participant of the Competition and / or legal representative authorized for dissemination (Appendix No. 7 to the present Regulations), consents to the use of photographs of the minor Participant of the Competition and / or legal representative (Appendix No. 8 and / or No. 9 to the present Regulations), as well as gives the Organizer consent to use the data specified in their application in the following ways: playback, distribution, public display, public performance, broadcasting and cablecasting, putting in the public domain via publishing on the Internet and being made accessible for all countries for participation in the Competition.

7.6. The Submitter is to provide authenticated relevant information in the Website registration form. The provision of unauthenticated information in the form is the basis for disqualification of the Participant of the Competition. The Organizer reserves the right to request authentication of the data provided in the form by contacting the Submitter

or the Applicant. The Submitter (parent and / or legal representative of a minor Applicant) assures that they will independently settle claims of third parties if such claims are made in relation to the information specified in the applications sent to the Competition.

7.7. An Applicant that became a Nominee or a Winner of the Competition in 2025 may not participate in the Competition with the enlightenment activity used in the previous year's Competition.

7.8. The changing of the nomination for the application of a Participant by the Organizer depending on the recommendations from the Commission and / or the Council is permitted.

7.9. Applicants become Participants of the Competition by fulfilling the following conditions:

7.9.1. Completion of registration by the Submitter and submission of the application of an Applicant on the Website within the time frame specified in clause 4.1.1 of the present Regulations.

7.9.2. Provision of information on enlightenment activities and achievements of the Participant of the Competition within the time frame specified in clause 4.1.1 of the present Regulations.

7.9.3. The Participant's compliance with the requirements specified in clause 7.1 of the present Regulations.

7.9.4. The application successfully passing the Organizer's preliminary evaluation.

7.10. The Participants of the Competition (parents and / or legal representatives of a minor Applicant) are obliged to respect the rights of third parties with respect to the results of intellectual activity used in the materials submitted to the Organizer, in accordance with the current legislation of the Russian Federation, and assure that they will independently settle claims of third parties if such claims are made.

7.11. The Participants of the Competition (parents and / or legal representatives of a minor Applicant) grant the Organizer the right to publish the materials provided by these individuals to the Organizer on the Website as well as to use them in the following ways: playback, distribution, public display, public performance, broadcasting and cablecasting, putting in the public domain via publishing on the Internet and being made accessible for all countries for participation in the Competition.

7.12. The official languages of reference of the Competition for the nomination "Foreign Enlightener" are Russian and English.

7.13. Participants of the Competition for the nominations "Foreign Enlightener" and "Young Enlightener" do not participate in the nominations "People's Choice" and "Choice of the First".

8. The procedure for determining Applicants for nomination, Nominees and Winners of the Competition

8.1. Applicants for nomination, Nominees and Winners of the Competition are determined in accordance with the following criteria:

- social significance (the importance and relevance of the enlightenment activities carried out by the nominee);
- scope and coverage (geographical features of the nominee's enlightenment activities and the number of people involved in the process);

– uniqueness (the use of new approaches, formats and tools in the field of enlightenment).

8.2. The criteria provided in clause 8.1 of the present Regulation are evaluated on the scale of 0 to 10 points.

8.3. The evaluation shall be conducted in accordance with the Methodical recommendations on the evaluation of applications for the annual Competition for the Enlightenment Award Znanie.Award – 2026 (hereinafter referred to as the Methodical recommendations) (Appendix No. 2 to the present Regulations).

8.4. An average score and / or rating of an application (a Participant, an Applicant for nomination or a Nominee) is formed based on the results of evaluation at the stages of the Competition. The average score is formed as an arithmetic mean of the expert evaluations given to an application (a Participant, an Applicant for nomination or a Nominee). The scores (rating) of different stages are not summarized. An application (a Participant, an Applicant for nomination or a Nominee) with a higher average score takes a higher place in the rating. If the average score of two or more applications (Participants, Applicants for nomination or Nominees) coincides, the application (a Participant, an Applicant for nomination or a Nominee) with the highest average score on individual evaluation criteria takes the higher place in the rating in the following order: "social significance", "scope and coverage", "uniqueness". In case of equality of the average score for all three criteria, the decision-making is entrusted to the Organizer represented by the General Director.

8.5. All applications received for the Competition are subject to preliminary evaluation of the Organizer for completeness of the data filled out and compliance with the requirements of the present Regulations.

8.6. At the Qualifying stage of the Competition, each application admitted for evaluation based on the results of preliminary evaluation shall be evaluated by at least 3 (three) experts of the Commission. At least 10 (ten) applications in each category of each nomination that scored the maximum average score based on the results of the Qualifying stage shall be selected for the First stage of the Competition as Applicants for nomination.

8.7. At the First Stage of the Competition, the application of each Applicant for nomination shall be evaluated by at least 3 (three) independent experts of the Council. No less than 3 (three) and no more than 5 (five) Applicants for nomination in each category of each nomination that received the highest rating values according to the results of the evaluation become the Nominees of the Competition as Participants of the Second Stage.

8.8. To proceed with participation in the Competition, Nominees shall provide the following documents in written form: consent of the personal data subject to the processing of personal data (Appendix No. 6 to the present Regulations), the Consent of the personal data subject to the processing of personal data authorized for dissemination (Appendix No. 7 to the present Regulations), the Consent to the use of a citizen's photo image and video recording of the Speech (Appendix No. 8 or Appendix No. 9 to the present Regulations)

8.9. At the Second stage of the Competition, the Nominees of the Competition are evaluated by the Jury. The average score for each Nominee of the Competition is formed

according to the results of the Jury's evaluation. The Jury has the right to rank the Nominee on the score sheet without providing any detailed reasoning therefore.

8.10. At the Second stage of the Competition a defense of the enlightenment activities of the Nominees themselves or their representatives (for projects and companies) in front of the Jury members (hereinafter referred to as the In-person defense) shall be conducted in compliance with the following requirements:

- 1 (one) person is admitted for the In-person defense – a Nominee or a representative of a Nominee (for enlightenment projects and companies);
- the duration of one Speech for the In-person defense is no more than 2 (two) minutes;
- the defender is required to speak about the Nominee (themselves or the Nominee, project or company they represent) and the enlightenment activities and professional achievements of the Nominee (a project or a company);
- language of the Speech: Russian (for the nomination "Foreign Enlightener" – Russian or English with interpretation into Russian);
- formal style of clothing (branded clothing with logos of third-party organizations may be allowed provided the consent of the Organizer is obtained);
- the Speech is accompanied by animated slides in a single style created by the Organizer containing 3 (three) facts about the enlightenment activities of the Nominee, the Nominee's information and a timer counting down the time of the Speech;
- the use of additional graphic, audio and video materials and other visual materials during the In-person defense may be allowed provided the consent of the Organizer is obtained;
- constant reading of the text during the Speech is prohibited.

8.10.1. To prepare the Nominees for the Second stage of the Competition, the Organizer of the Competition provides an offline and online enlightenment program featuring lectures, workshops, trainings, consultations and other formats. The conditions and procedure for organizing Speakers' Speeches for the enlightenment program are approved by the Regulations on the organization of Speakers' Speeches within the framework of enlightenment activities of the Russian "Znanie" Society, approved by the order of the Russian "Znanie" Society.

8.10.2. In the event of inability to attend the In-person defense of enlightenment activities and with the consent of the Organizer, the Nominees may submit a video recording (hereinafter referred to as the Video) of their Speech in the format of a presentation of their enlightenment activities to the Jury for the In-person defense by sending it to the e-mail address of the Organizer: premiya@znanierussia.ru, no later than 7 (seven) calendar days before the date of the In-person defense of enlightenment activities, or by attaching their video when submitting their application for the Competition. The Video is required to feature the Participant speaking about themselves, their enlightenment activities and achievements.

8.10.3. Requirements for the Video:

- duration: no more than 2 (two) minutes;
- video orientation: horizontal;

- aspect ratio: 16:9;
- video resolution: 1920 × 1080;
- video size: no more than 1 GB;
- language: Russian or English;
- absence of noises, echo and other audio and video disturbances, a neutral background;
- the Participant is to be presented alone in the frame, they are to be audible and visible, constant reading during the Speech is prohibited;
- formal dress code, absence of third-party organization logos and branding;
- the Video must not feature falsification of scientific or any other type of research;
- the Video must not contain calls for extremist activity; public incitement, justification of or arguing for extremism, social, racial, national or religious discord, humiliation of national dignity, propagating discrimination, superiority or inferiority of citizens on the basis of their attitude to religion, social, racial, national, religious or linguistic affiliation or other reasons; propagating and publicly displaying Nazi paraphernalia or symbols, or paraphernalia or symbols similar to Nazi paraphernalia or symbols to the extent of their confusion.

8.10.4. Videos that do not comply with the requirements of the present Regulations may not be admitted to the In-person defense and instead the moderator shall read out the description of the Nominee's enlightenment activities.

8.10.5. By sending the Video to the e-mail address of the Organizer of the Competition: premiya@znanierussia.ru the Participant (the submitter) grants the Organizer the right to publish the Video, including the information distributed by the Nominee as part of the Video, the right to use the image of the Nominee recorded in the Video, according to Article 152.1 of the Civil Code of the Russian Federation. Additionally, the Participant grants the Organizer the right to further use the Video for the purpose of the Nominee's participation in the "Foreign Enlightener" nomination, as well as for the statutory purposes of the Organizer in the following ways: reproduction, distribution, public display, public performance, broadcast and cable transmission, publication via posting the Video on the Internet and being made accessible for all countries, on the information resources of the Organizer, in the group (community) on the page on the VKontakte social network (vk.com/znanierussia) and on the Website of the Competition.

8.11. The Winner of the Competition (except for the nominations "Choice of the First", "People's Choice" and "For General Contribution to Enlightenment") is one Nominee in each of the categories of each nomination who received the highest place in the rating based on the results of the Second stage of the Competition.

8.12. The Nominees who scored the most points in the online public voting in MAX in the categories "Enlightener" and "Enlightenment Project" become the Winners in the nomination "People's Choice".

8.13. The Nominee from the "Enlightener" category who scored the highest number of points according to the results of the closed voting of the Federal Council of the First becomes the Winner in the "Choice of the First" nomination. Voting in accordance with the requirements of these Regulations shall be organized by the All-Russian

Public-Government Movement of Children and Youth "Movement of the First". Each member of the Federal Council of the First has one vote. The Winner is chosen by a simple majority of votes. In case of disputes, a remote meeting of the Federal Council of the First is held. The meeting is valid if at least 50 percent of the members of the Federal Council of the First take part in it.

8.14. The Winners in the nomination "For general contribution to enlightenment" in the categories "Enlightener" and "Enlightenment project" are selected from among all the Nominees of the respective categories by the Jury members based on the results of the In-person defense of the enlightenment activities at the Second stage of the Competition;

8.15. The best Enlighteners and Enlightenment projects that have made a significant contribution to the enlightenment activities of their constituent entity of the Russian Federation will be determined based on the results of the expert evaluation.

9. Prizes and awards for the Winner of the Competition

9.1. Participants of the Competition shall receive a certificate of participation in digital form

9.2. The Winners of the Competition are entitled to:

9.2.1. The title of the Winner of the Enlightenment Award Znanie.Award of the Russian "Znanie" Society.

9.2.2. Support for the enlightenment activities of the Winners of the Competition by the Organizer and the opportunity to participate in future events held by the Organizer.

9.2.3. Diplomas and memorable prizes from the Organizer of the Competition.

9.3. The Nominees and Winners of the Competition and the Competitions held in the previous years may be invited to the events held by the Russian "Znanie" Society as members of expert groups and/or Speakers in order to enlighten and inform about the Competition. The conditions and procedure for organizing Speakers' presentations are approved by the Regulations on the organization of Speakers' presentations within the framework of enlightenment activities of the Russian "Znanie" Society approved by the order of the Russian "Znanie" Society.

10. Organizer and Competition partners

10.1. The Organizer of the Competition assumes the following responsibilities:

10.1.1. Development of the evaluation methodology, the procedure for conducting the Competition and other regulatory documents required to conduct the Competition.

10.1.2. Provision of IT support for the Competition.

10.1.3. The organization of all stages of the Competition.

10.1.4. Regulating other issues pertaining to the organization of the Competition.

10.2. The Organizer may provide the following:

– logistics services (including transfer, bus, railway and air tickets from the place of residence/stay to the venue of the Competition events and from the venue of the Competition events to the place of residence/stay) and accommodation for the Nominees of the Competition, Winners and the Nominees of the Competitions held in the previous years during the organization and execution of the events within

the framework of the Competition, including the Second stage of the Competition and the stage of the Award ceremony;

- logistics services (including transfer, bus, railway and air tickets from the place of residence/stay to the venue of the Competition events and from the venue of the Competition events to the place of residence/stay) and accommodation by the Organizer's decision for no more than one individual accompanying a Nominee for the categories "Enlightener", "Enlightenment project" and "Enlightenment company", as well as for the individuals accompanying for medical reasons, individuals accompanying the minor participants during the organization and execution of the events within the framework of the Competition, including the Second stage of the Competition and the stage of the Award ceremony;

- transportation, as determined by the Organizer, from the Participant's place of residence or stay to the venue of the Competition events and from the venue of the Competition events back to the Participant's place of residence or stay, for other participants during the organization and execution of the events within the framework of the Competition, including the Second stage of the Competition and the stage of the Award ceremony;

- provision of meals and hydration for the Nominees and other participants of the events within the framework of the Competition, including during the organization and execution of the Second stage of the Competition and at the stage of the Award ceremony if the duration of time spent at the event is four hours and upwards.

10.3. In case of failure by the Nominee of the Competition and / or other participant of the events within the framework of the Competition for whom logistics services were arranged to board the flight or their refusal to travel, as well as in case of failure to provide boarding passes to the Organizer, in case of refusal of the Nominee of the Competition and / or other participant of the events within the framework of the Competition who was provided with accommodation to stay at the booked hotel, the Organizer reserves the right to demand a refund of the funds spent by the Organizer on providing travel and / or accommodation for the Nominee and / or other participant of the events within the framework of the Competition from the Nominee of the Competition and / or other participant of the events within the framework of the Competition.

10.4. At the end of the First and the Second stages of the Competition, as well as during the Award ceremony the Organizer and / or the Organizer / the Competition partners may provide awards, souvenirs and promotional items for the Nominees and / or other participants of the events within the framework of the Competition, including the organization and execution of the Second stage of the Competition and the stage of the Award ceremony.

11. Final provisions

11.1. The Organizer reserves the right to immediately suspend or terminate the rights of the Participants of the Competition in case they violate the present Regulations or other local regulations establishing the rules for conducting the Competition or its stages.

11.2. The following criteria may also be grounds for exclusion from participation in the Competition:

- a) submission for exclusion from the Competition made by a Participant, an Applicant

for nomination or a Nominee;

a) submission for exclusion from the Competition made by a Participant, an Applicant for nomination or a Nominee;

c) publication of information and data violating the current legislation of the Russian Federation;

d) violation of third-party rights to the results of intellectual activity submitted to the Organizer by a Submitter, an Applicant for nomination or a Nominee of the Competition;

e) a prior criminal conviction (whether canceled or removed) or conviction to punishment by a court verdict that has entered into force, being under investigation, disqualification from public office by a court decision;

f) calls for extremist activity; public incitement, justification of or arguing for extremism, social, racial, national or religious discord, humiliation of national dignity, propagating discrimination, superiority or inferiority of citizens on the basis of their attitude to religion, social, racial, national, religious or linguistic affiliation or other reasons; propagating and publicly displaying Nazi paraphernalia or symbols, or paraphernalia or symbols similar to Nazi paraphernalia or symbols to the extent of their confusion;

g) publications on the Organizer's Website and official social media pages (VKontakte) in the form of text messages, graphic and/or video files or other forms of communication involving content that is offensive to Applicants for nomination or Nominees, citizens who support the Participants, or other persons, or may be regarded as such, as well as information discrediting the Participants, citizens who support the Participants, or other persons, containing threats, calling for violence, the commission of illegal, antisocial, or immoral acts, as well as the commission of any other actions contrary to the foundations of law and order and morality;

h) publication of false or defamatory information regarding the Competition, the Applicants for nomination and / or Nominees, or citizens who support them;

i) use of data from the fields of pseudoscience and falsification of scientific research;

k) the dissemination of destructive ideology aimed at the following:

– creating conditions for the self-destruction of society and weakening family, friendship, and other social ties;

– exacerbating sociocultural divisions within society, diminishing the role of social partnership, and devaluing the ideals of creative labor and mutual aid;

– causing harm to people's moral well-being, imposing ideas that deny human dignity and the value of human life;

– introducing antisocial behavioral stereotypes, promoting an immoral lifestyle, permissiveness, and violence, and increasing alcohol and drug use;

– forming a society that disregards spiritual and moral values;

– distorting historical truth, destroying historical memory;

– denying Russian identity, weakening pan-Russian civic identity and the unity of Russia's multinational people, creating conditions for interethnic and interreligious conflicts;

– undermining trust in state institutions, discrediting the idea of serving the Fatherland, and fostering a negative attitude toward military service and public service in general;

l) other actions of the Participant that contradict the foundations of morality

and/or the following traditional Russian spiritual and moral values: life, dignity, human rights and freedoms, patriotism, civic consciousness, service to the Fatherland and responsibility for its fate, high moral ideals, strong family values, creative labor, the priority of the spiritual over the material, humanism, mercy, justice, collectivism, mutual aid and mutual respect, historical memory and the continuity of generations, and the unity of the peoples of Russia.

11.3. the Organizer reserves the right to prevent from participating or remove from participation those suspected of non-compliance with the rules specified in clause **Ошибка!**
Источник **ССЫЛКИ** **НЕ** **найден.**
of the present Regulations from participating in the Competition with no explanation or evidence.

11.4. The Organizer of the Competition bears no responsibility for the nature and reliability of the information provided by the Participants of the Competition, as well as by citizens participating in events to support the Participants of the Competition, that becomes available to citizens during the Competition. Should any violation of the current legislation be identified during the Competition, including violations of the third party rights to the results of intellectual activity used by a Participant of the Competition, including any data used by an Enlightenment project that is a Participant of the Competition, violations of the rules of the Competition, including the publication of deliberately false information, the Organizer of the Competition has the right to exclude from further consideration for the Competition any Participant of the Competition who has committed this action, or a citizen who participates in supporting Participants of the Competition, as well as to remove all data published by them from public access.

11.5. The information on the procedure and rules for conducting the Competition specified in the present Regulations is posted on the Website.

11.6. Should any changes be made to the present Regulations, they are to be published on the Website. If a Participant of the Competition continues to participate in the Competition, they thereby agree with the changes made to the present Regulations.

List of nominations of the annual Competition for the Enlightenment Award Znanie.Award – 2026

Main nominations of the Competition

1. For Enlightenment Activities in an Educational Organization.

Categories: "Enlightener in the reschool Education System", "School Enlightener", "Enlightener in the Secondary Vocational Education System ", "University Enlightener".

The nomination for the individuals who introduce modern methods of education, expand the boundaries of traditional methods in their work with students of higher education institutions, secondary vocational education institutions and conducts educational and upbringing work at schools and preschools.

The nomination is open to the following Applicants: teachers, professors, associate professors, curators, methodologists, facilitators as well as rectors, vice-rectors, deans, heads of chair, principals, deputy principals, advisors to directors on education and interaction with children's non-governmental organizations, preschool teachers, educators and instructors, creators of enlightenment projects and etc.

2. For the Best Enlightening Book.

Categories: "Enlightenment project".

The nomination established to determine the best enlightening book presented in 2025-2026, regardless of its subject area.

3. For the Best Enlightening Movie.

Categories: "Enlightenment project".

The nomination established to determine the best enlightening movie presented in 2025-2026, including animation and cartoon movies, regardless of its subject area.

4. For Contribution to the Preservation of the unity of the peoples of Russia.

Categories: "Enlightener", "Enlightenment project".

The nomination for the Enlightenment projects and the Enlighteners that contribute to the reinforcement of interethnic peace and harmony, development of spiritual and moral foundations of society, as well as strengthening the institution of the family and promoting traditional values and cultural diversity to create a healthy and harmonious society.

The nomination is open to the following Applicants: representatives of ethnic and cultural organizations, teaching staff members, psychologists, culturologists, historians, public religious figures, creators of enlightenment projects, as well as initiatives aimed at fostering interethnic harmony and promoting traditional ways of life as the foundation of national unity.

5. For Contribution to Enlightenment in the Field of "Ecology and Tourism".

Categories: "Enlightener", "Enlightenment project".

The nomination for the Enlightenment projects and Enlighteners that develop and promote the tourist image of the country's regions and the culture of welcome, work to increase environmental responsibility and protection, nature conservation and biodiversity.

The nomination is open to the following Applicants: ecologists, researchers, tour guides, sustainable tourism experts, as well as environmental programs, touristic routes and etc.

6. For Contribution to the Preservation of the Memory of the Feats of the Defenders of the Fatherland.

Categories: "Enlightener", "Enlightenment project".

The nomination is for the educational projects and educators who are actively engaged in popularizing the heroic past and present of our country, the feats of the defenders of the Fatherland, preserving historical memory, as well as fostering patriotism and respect for the history of Russia.

The nomination is open to the following Applicants: historians, teachers, authors of books and documentaries, creators of museum exhibitions, organizers of patriotic campaigns, participants and Heroes of the Special Military Operation, war correspondents, as well as projects aimed at preserving and commemorating the feats of the defenders of the Fatherland, including memorial initiatives, educational programs, multimedia products and social movements.

7. For Contribution to Enlightenment in the Field of "Science and Technology".

Categories: "Enlightener", "Enlightenment project".

The nomination for the Enlightenment projects and Enlighteners that actively engage in scientific activities, popularization of science and development of scientific and technological potential of the country, facilitate active application of new technologies in various fields, as well as promote the latest scientific discoveries and achievements, and new technologies. The nomination is timed to coincide with the Decade of Science and Technology.

The nomination is open to the following Applicants: scientists, inventors, technologists, academic specialists, information technology experts, as well as scientific academic competitions, technology programs and etc.

8. For Contribution to Enlightenment in the Field of "Economics, Business and Law".

Categories: "Enlightener", "Enlightenment project".

The nomination for the Enlightenment projects and Enlighteners that carry out active work related to law, financial and investment literacy, development of entrepreneurial skills, as well as economy growth prospects, legal awareness and literacy.

The nomination is open to the following Applicants: entrepreneurs, lawyers, economists, tax consultants, diplomats, as well as digital platforms, business trainings and etc.

9. For Contribution to Enlightenment in the Field of "Culture and Arts".

Categories: "Enlightener", "Enlightenment project".

The nomination for the Enlightenment projects and Enlighteners that carry out activities related to the cultural heritage of Russia, popularization of creative work and art along with the history of culture and art.

The nomination is open to the following Applicants: musicians, artists, actors, directors, art critics, as well as art exhibitions, creative festivals, theatrical productions and etc.

10. For Contribution to Enlightenment in the Field of "History".

Categories: "Enlightener", "Enlightenment project".

The nomination for the Enlighteners and Enlightenment projects that promote popularization of knowledge in the field of history, objective coverage of historical processes, as well as the development of a deep understanding of the relationship between history and modern life.

The nomination is open to the following Applicants: historians, teachers, authors of books, documentaries and scientific research, creators of educational programs, as well as projects aimed at enlightenment in the field of history. These may include lectures, publications, multimedia products, discussion clubs, educational platforms and other initiatives.

11. For Contribution to Enlightenment in the Field of "Health and Sports".

Categories: "Enlightener", "Enlightenment project".

The nomination for the Enlightenment projects and Enlighteners that promote a responsible approach to health, raise awareness of health literacy, and support disease prevention, as well as the development of sports, adaptive physical education, and motivation to lead a healthy lifestyle.

The nomination is open to the following Applicants: doctors, medical experts, healthcare professionals, athletes, coaches, sports journalists, organizers of physical culture and sports work, nutritionists, as well as projects focused on health education, sports events, and health promotion initiatives.

12. Young Enlightener.

Categories: "Enlightener".

The nomination for the young people aged 12 to 17 who carry out active enlightenment activities in various fields, implement educational, training, informative initiatives and projects, teach classes or conduct lectures for school students, are authors of scientific and research works and inspire others by their example.

13. Foreign Enlightener.

Categories: "Enlightener".

The nomination for the foreign citizens who implement enlightenment initiatives and projects that have a positive impact on the development and strengthening of relations between the Russian Federation and other countries. The Award is for those who fight falsification and objectively cover historical facts about Russia, promote information on new opportunities and prospects within the country and its crucial role in the various fields of the international scene.

14. Enlightenment Company of the Year.

Categories: "Enlightenment company".

The nomination for the organizations that implement a set of activities or projects aimed at enlightenment, as well as raising the scientific, educational and cultural level of citizens in addition to their main activities. The prize is awarded to a legal entity for outstanding achievements in the field of enlightenment in 2025-2026.

15. For Contribution to Enlightenment in the Field of "Learning and Mentoring".

Categories: "Enlightener", "Enlightenment project".

The nomination is intended for the Enlighteners and Enlightenment projects that promote a culture of learning and mentoring, and create conditions for intergenerational and interprofessional transfer of knowledge, skills and experience.

The nomination is open to the following Applicants: teaching staff members, mentors, trainers, creators of training programs, as well as projects aimed at the development of training and mentoring. That includes educational platforms, mentoring programs, courses, trainings, experience sharing initiatives and other projects that promote effective learning, personal and professional growth.

16. The Sergei Ivanovich Vavilov Nomination.

Categories: "Enlightener".

The nomination for Lecturers-Enlighteners who follow in the footsteps of Academician Sergei Ivanovich Vavilov, the first chairman of the All-Union "Znanie" Society, established to recognize contributions to the development of lecturing skills and the strengthening of traditions of Russian enlightenment. The achievements evaluated include both long-term dedication to the chosen field and significant efforts in promoting reliable knowledge.

The nomination is open to the following Applicants: lecturers, scholars, educators, public figures and staff members of enlightenment organizations who demonstrate a highly professional approach to their work in the field of enlightening activities.

Special nominations of the Competition

17. Choice of the First.

Categories: "Enlightener".

The Winner is determined among the Nominees of the "Enlightener"* category by closed voting of the Federal Council of the First, which includes children and adolescents from all constituent entities of the Russian Federation.

* – *except for the nominations "Foreign Enlightener" and "Young Enlightener".*

18. People's choice.

Categories: "Enlightener", "Enlightenment project".

The Award for outstanding achievements in the field of enlightenment in 2025-2026 with the Winners chosen from among the Nominees of "Enlightener"* and "Enlightenment project" categories regardless of the subject area. The Winners are determined by open voting of listeners in the MAX group.

* – *except for the nominations "Foreign Enlightener" and "Young Enlightener".*

19. For General Contribution to Enlightenment.

Categories: "Enlightener", "Enlightenment project".

The Award for outstanding achievements in the field of enlightenment in 2025-2026 with the Winners chosen from among the Nominees of "Enlightener" and "Enlightenment project" categories regardless of the subject area. The winners are determined by voting of the Jury panel based on the results of the In-person presentation of the enlightenment activities of the Nominees.

**Personal data processing policy
used for conducting the annual Competition
for the Enlightenment Award Znanie.Award – 2026**

1. General provisions

1.1. The Personal data processing policy used for conducting the annual Competition for the Enlightenment Award Znanie.Award – 2026 (hereinafter referred to as the present Personal data processing policy / the present Policy / the Policy) defines the procedure for processing personal data and ensuring its security during the annual Competition for the Enlightenment Award Znanie.Award – 2026 (hereinafter referred to as the Competition) in order to protect human and civil rights and freedoms in the processing of personal data, including protection of the rights to privacy, personal and family secrets.

1.2. The present Policy has been developed in accordance with the Federal Law No. 152-FZ of July 27, 2006 "On Personal Data" (hereinafter referred to as Law No. 152-FZ).

1.3. The purposes of personal data processing correspond to and are aimed at implementing the Regulations on the Competition. Personal data processing is carried out for the purpose of conducting the Competition, processing, analysis, audit and accounting of persons who have been registered on the Website of the Competition and/or are participating in the Competition. Another purpose is notifying the individuals participating in the Competition regarding the news, changes in the conditions of the Competition and the results of the Competition and other information provided for by the Regulations on the Competition, as well as encouraging the Participants who demonstrated high results during the Competition.

1.4. All issues related to personal data processing that are not regulated by the present Personal data processing policy and / or the general personal data processing policy are resolved in accordance with the current legislation of the Russian Federation regarding personal data.

1.5. The following terms and definitions are used in the present Policy:

– the Operator – a state body, municipal body, legal entity or an individual, independently or jointly with other persons organizing and / or carrying out personal data processing, as well as determining the purposes of personal data processing, the contents of personal data to be processed, actions (operations) performed with personal data;

– personal data – any information related directly or indirectly to a specific or identifiable individual (subject of personal data);

– personal data processing – any action (operation) or set of actions (operations) performed with personal data with or without the use of automation tools, including collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (distribution, sharing, access), depersonalization, blocking, deletion, destruction of personal data;

– automated personal data processing – personal data processing using computer technology;

– dissemination of personal data – actions aimed at disclosing personal data to an indefinite circle of persons (transfer of personal data) or familiarization with personal data of an unlimited number of persons, including publication of personal data in the media, posting in information and telecommunication networks or providing access to personal data in any other way;

– provision of personal data – actions aimed at disclosing personal data to a certain person

or a certain circle of persons;

- blocking of personal data – temporary termination of the personal data processing (except in cases where processing is necessary to clarify personal data);

- destruction of personal data – actions as a result of which it is impossible to restore the content of personal data in the personal data information system and / or the physical media carrying personal data is destroyed;

- depersonalization of personal data – an action as a result of which it is impossible to determine the specific personal data subject without using additional information;

- personal data information system – a set of personal data contained in databases, as well as information technologies and technical means that ensure its processing.

1.6. The Policy applies to all personal data of Applicants for nomination / Creators and / or Copyright holders of an Applicant for nomination / Nominee being an Enlightenment project / Nominee of the Competition / Winner of the Competition processed during the Competition with or without the use of automation tools. The personal data of citizens who, in accordance with the present Regulations, support Applicants for nomination or Nominees, are not collected and processed by the Operator.

1.7. The present Policy is a publicly available document and is subject to be posted on the official Website of the Competition <https://znanierussia.ru/premiya> (hereinafter referred to as the Website).

2. Information about the Operator

3. Legal grounds for personal data processing

3.1. The legal grounds for personal data processing include:

- The Constitution of the Russian Federation;

- The Labor Code of the Russian Federation;

- The Civil Code of the Russian Federation;

- Federal Law No. 149-FZ of July 27, 2006 "On Information, Informational Technologies and the Protection of Information";

- Federal Law No. 63-FZ of April 6, 2011 "On Electronic Signature";

- Federal Law No. 160-FZ of December 19, 2005 "On Ratification of the Council of Europe Convention for the Protection of Individuals with Regard to Automatic Processing of Personal Data";

- Federal Law No. 126-FZ of July 7, 2003 "On Communications";

- Federal Law No. 27-FZ of April 1, 1996 "On Individual (Personal) Registration in the System of Compulsory Pension Insurance";

- Federal Law No. 243-FZ of July 3, 2016 "On the Amendments to Parts I and II of the Russian Federation Tax Code Due to the Transfer of Authority Over Administration of Pension, Social and Medical Insurance Payments to the Tax Authorities";

- Federal Law No. 273-FZ of December 29, 2012 "On Education in the Russian Federation";

- Federal Law No. 125-FZ of October 22, 2004 "On Archival Affairs in the Russian Federation";

- Resolution of the Government of the Russian Federation No. 1119 of November 1, 2012 "On approval of requirements for the protection of personal data during their processing in personal data information systems";

– Resolution of the Government of the Russian Federation No. 687 of September 15, 2008 "On approval of the Regulation on peculiarities of personal data processing carried out without the use of the automated tools";

- contracts and agreements signed by one of the parties under which the Organization acts;
- the consent of the personal data subject to personal data processing;
- other regulatory legal acts.

4. Principles and conditions for the personal data processing

4.1. Personal data processing within the framework of the Competition is carried out on the basis of the following principles:

- legality and fairness;
- restrictions on personal data processing to the achievement of specific, predetermined and legitimate purposes;
- ensuring that the scope of personal data processed corresponds to the processing purposes;
- restricting the integration of databases containing personal data processed for incompatible purposes;
- processing only the personal data that meet the purposes of the processing;
- compliance of the content and volume of the processed personal data with the stated purposes of processing;
- restricting excessive personal data processing in relation to the stated processing purposes;
- ensuring the accuracy, sufficiency and relevance of personal data in relation to the purposes of personal data processing;
- destruction or depersonalization of personal data after the processing purpose has been achieved or if the purpose no longer needs to be achieved.

4.2. Personal data may be processed within the framework of the Competition only where at least one of the following conditions is met:

- personal data processing is carried out with the consent of the personal data subject to the processing of their personal data;
- personal data processing is necessary to achieve the purposes stipulated by the law, to exercise and perform the functions, powers and duties vested in the Operator by the legislation of the Russian Federation;
- personal data processing is necessary to perform a contract, where the personal data subject is a party, beneficiary or a guarantor, including the right of the Operator to assign rights (claims) under such a contract, as well as to perform a contract on the initiative of the personal data subject or a contract, where the personal data subject is a beneficiary or a guarantor;
- personal data processing is necessary to implement the rights and legitimate interests of the Operator or third parties or to achieve important public purposes, provided that doing so does not violate the rights and freedoms of the personal data subject;
- personal data processing is carried out and access to it is provided to an unlimited number of persons by the personal data subject or at their request (hereinafter referred to as the Publicly available personal data);
- personal data processing subject to publishing or mandatory disclosure in accordance with federal law is carried out.

4.3. The Operator and other persons with access to personal data must not disclose to third parties or disseminate personal data without the consent of the personal data subject, unless otherwise stipulated by the federal law.

In accordance with Part 1 of Article 10.1 of Law No. 152-FZ, consent to personal data processing authorized by the personal data subject for dissemination shall be issued separately from other consents of the personal data subject to the processing of their personal data. The Operator is obliged to provide the personal data subject with the opportunity to determine the list of personal data for each category

of personal data specified in the consent to personal data processing authorized by the subject of personal data for dissemination.

At the same time, according to Part 2 of Article 10.1 of Law No. 152-FZ, in the case of disclosure of personal data to an indefinite circle of persons by the personal data subject themselves without providing the Operator with consent to the processing of personal data authorized by the subject of personal data for dissemination, the obligation to provide evidence of the legality of subsequent dissemination or other processing of such personal data lies with each person who carried out their dissemination or other kind of processing.

4.4. The Operator is entitled to entrust personal data processing to another person with the consent of the personal data subject, unless otherwise established by federal law. The person processing personal data on behalf of the Operator is obliged to comply with the principles and rules of personal data processing stipulated by Law No. 152-FZ.

4.5. Personal data shall be stored, processed and used during and after the Competition, and the personal data of the Winner of the Competition shall be stored, processed and used after the Competition in order to encourage professional and personal development. Termination of processing occurs upon withdrawing consent to personal data processing by the personal data subject (or their representative), taking into account the conditions stipulated in Article 21 of Law No. 152-FZ or upon expiration of the Consent to personal data processing.

4.6. The volume and categories of personal data processed and categories of personal data subjects:

4.6.1. The following personal data of the Applicant for the nomination, the creator and/or the copyright holder of the Applicant for nomination / Nominee participating as an Enlightenment project / Nominee of the Competition or the Winner are processed by the Operator for the purpose of the Competition:

- full legal name;
- date of birth, place of birth;
- citizenship (nationality);
- sex;
- identifying document (type, serial number, individual number, issue date, designation of the issuing authority), including a scanned copy of the passport;
- address and date of registration at the place of residence (place of stay), address of actual residence (including the federal district and the subject of the Russian Federation);
- birth certificate;
- taxpayer ID number (if required);
- personal insurance policy number (if required);
- bank details (if required);
- the field of activity of the Applicant for nomination / creator and/or copyright holder of the Applicant for nomination / Nominee participating as an Enlightenment project / Nominee of the Competition, their current held post, industry, employer and other information about the current and previous places of work and / or service;
- information about the activities (credentials), information about the experience of the Applicant for nomination / creator and / or copyright holder of the Applicant for nomination / Nominee participating as an Enlightenment project / Nominee of the Competition;
- phone number, email address, social media accounts, including the number of subscribers, or information about other communication methods;
- information about education, profession and qualifications; place of education, class, course;
- held post;
- place of work;
- information specified in the form, biography;
- author's work (work credits);
- photo image of the Applicant for nomination / creator and / or copyright holder of the Applicant for nomination / Nominee participating as an Enlightenment project / Nominee of the Competition;

- audio recording;
- video recording of the Applicant for nomination / creator and / or copyright holder of the Applicant for nomination / Nominee participating as an Enlightenment project / Nominee of the Competition (including a personal photo and video archive provided by oneself (if applicable) and professional filming of audio-visual works);
- hobbies;
- Website ID;
- IP address;
- Cookie files;
- information about the actions performed on the Website;
- information about the devices and browsers used;
- in order to achieve the purposes of analyzing the individuals participating in the Competition, the Operator may also use social network data.

Special category of personal data:

- information about the state of health: information about the delivery and results of laboratory tests for the new coronavirus infection COVID-19 by PCR testing (if required).

Personal data of a third party (submitter) nominating an Applicant for nomination, members of the Jury, members of the Commission and Expert council, distinguished Guests are processed by the Operator in order to implement the conditions of the Competition:

- full legal name;
- date of birth, place of birth;
- sex;
- citizenship (nationality);
- identifying document (type, serial number, individual number, issue date, designation of the issuing authority), including a scanned copy of the passport;
- address;
- held post;
- place of work;
- experience as an expert and / or evaluator of competitive works, applications (including grant competitions) (for applicants for membership in the Expert council or Expert commission);
- information about the work field (credentials);
- information specified in the form;
- photo image;
- audio recording;
- video recording;
- contact information (phone number, email address, social network links);
- Website ID;
- IP address;
- Cookie files;
- information about the actions performed on the Website;
- information about the devices and browsers used.

Personal data of Guests and spectators processed by the Operator in order to implement the terms of the Competition include the following:

- full legal name;
- date of birth, place of birth;
- sex;
- identifying document (type, serial number, individual number, issue date, designation of the issuing authority), including a scanned copy of the passport;
- address;
- citizenship (nationality);
- held post;

- place of work;
- photo image;
- audio recording;
- video recording;
- contact information (phone number, email address, social network links);
- Website ID;
- IP address;
- Cookie files;
- information about the actions performed on the Website;
- information about the devices and browsers used.

A special category of personal data for the above categories of subjects may be processed if required:

- information about the state of health: information about the delivery and results of laboratory tests for the new coronavirus infection COVID-19 by PCR testing.

The exact list may be stipulated in the consent to the processing of personal data.

4.7. Application procedure:

4.7.1. The Applicant for nomination in the Competition registers on the Website independently or the registration is carried out by the legal representative of the Applicant.

When registering on the Website, the user familiarizes themselves with the Privacy Policy, the Regulations on the procedure and organization of the annual Competition for the Enlightenment Award Znanie.Award – 2026, the Policy of processing personal data during the annual Competition for the Enlightenment Award Znanie.Award – 2026, accepts the terms, and also accepts the agreement on the use of a simple electronic signature, gives consent to the processing of personal data. Provided the above-mentioned criteria are met, they may apply for participation in the Competition.

4.7.2. Third parties (Submitters) registering Applicants for nomination may register on the Website in advance. When registering on the Website third parties familiarize themselves with the Privacy Policy, the Regulations on the procedure and organization of the annual Competition for the Enlightenment Award Znanie.Award – 2026, the Policy of processing personal data during the annual Competition for the Enlightenment Award Znanie.Award – 2026 and accept the terms, as well as accept the agreement on the use of a simple electronic signature and consent to the processing of their personal data.

Furthermore, the third party confirms that the personal data of the Applicant for nomination has been provided and subsequently received by the Organizer on a legitimate basis. Provided the above-mentioned criteria are met, the third party may apply (submit an Applicant for nomination) to participate in the Competition. The Organizer reserves the right to request confirmation of the data specified in the application by contacting the Participants or third parties by e-mail or phone.

4.8. The shortlisted Nominees of the Competition, determined by the results of the work of the Council, give their consent to the processing of personal data in the form specified in Appendix No. 6-8.

5. The procedure and conditions for the personal data processing

5.1. The personal data processing shall be carried out by the Operator in accordance with the requirements of the legislation of the Russian Federation.

5.2. The personal data processing includes the following list of actions: collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

5.3. The personal data processing in the Organization shall be carried out in the following ways: without the use of computer equipment (non-automated personal data processing); automated personal data processing with or without transmission of the data received via information and telecommunication networks; mixed personal data processing.

5.4. The personal data processing in the Organization shall be carried out considering the necessity to ensure the protection of the rights and freedoms of the employees of the Organization and other personal data subjects, including the protection of the right to personal and family privacy, based on the following principles:

- personal data processing in the Organization shall be carried out on a legal and equitable basis;
- personal data processing shall be limited to the achievement of specific, predetermined and legitimate purposes. Personal data processing incompatible with the purposes of personal data collection is not allowed;
- the integration of databases containing personal data processed for incompatible purposes is not allowed;
- personal data shall be reliable, only personal data that meets the processing purposes is subject to processing;
- the content and scope of the processed personal data shall correspond to the stated processing purposes. Excessive personal data processing in relation to the stated processing purposes is not allowed;
- the accuracy, sufficiency, and, if necessary, relevance of personal data in relation to the personal data processing purposes shall be ensured. The Organization shall implement the necessary measures or ensure their implementation to delete or clarify incomplete or inaccurate personal data;
- personal data storage shall be carried out in a form allowing to identify the personal data subject for no longer than the personal data processing purposes require, unless the period of personal data storage is established by federal law or by a contract, where the personal data subject is a party, beneficiary or guarantor;
- the processed personal data shall be destroyed or depersonalized upon achievement of the purposes of processing or in case of loss of necessity to achieve these purposes, unless otherwise established by federal law.

5.5. Personal data may be processed only where at least one of the following conditions is met:

- personal data shall be processed with the consent of the personal data subject to the personal data processing;
- personal data processing is necessary to achieve the purposes stipulated by the law, to exercise and perform the functions, powers and duties vested in the Operator by the legislation of the Russian Federation;
- personal data processing is necessary to perform a contract, where the personal data subject is a party, beneficiary or a guarantor, including the right of the Operator to assign rights (claims) under such a contract, as well as to perform a contract on the initiative of the personal data subject or a contract, where the personal data subject is a beneficiary or a guarantor;
- personal data processing is necessary to implement the rights and legitimate interests of the Operator or third parties or to achieve important public purposes, provided that doing so does not violate the rights and freedoms of the personal data subject;
- publicly available personal data processing is carried out;
- personal data processing subject to publishing or mandatory disclosure in accordance with federal law is carried out.

5.6. The Operator and other persons with access to personal data must not disclose to third parties or disseminate personal data without the consent of the personal data subject, unless otherwise established by federal law.

5.7. Information about third parties involved in the personal data processing.

The Operator shall provide access to personal data to the following organizations in the course of its operations to ensure the compliance with the legislation of the Russian Federation, to achieve the purposes of personal data processing, as well as in the interest and with the consent of the personal data subjects:

- to licensing and / or controlling bodies of state power and local self-governed body;
- to other organizations in accordance with the legislation of the Russian Federation.

5.8. With the consent of the personal data subject, the Operator shall transfer the personal data of the Nominees / creators and / or copyright holders of an Enlightenment project chosen as a Nominee / Winner of the Competition who have achieved high results, to representatives of state authorities and other organizations performing operations for their promotion and development to ensure the achievement of the purposes of the Competition specified in the Regulations on the Competition.

The Operator is entitled to place ratings of the Nominees of the Competition with indication of individual places in the rating during the online voting on the Website. The rating and other information about the Nominees, the Winners of the Competition and the results of the Competition may be published in the media.

To ensure participation in the Competition in accordance with the present Regulations on the Competition and to the extent necessary to achieve the purposes of the Competition, personal data of an Applicant for nomination, creator and / or copyright holder of an Applicant for nomination / a Nominee of the Competition, may be processed by the Commission, the Council, the Jury panel, Partners of the Organization, individuals under civil law contracts, organizations providing logistics and accommodation services, as well as an Organization providing educational services in preparation for the First or Second stages of the Competition; organizations providing other related services within the framework of the Competition.

6. Rights and obligations of the personal data subject

6.1. The personal data subject shall decide on the provision of personal data and give consent to their processing freely, willingly and their own interest. Consent to the personal data processing may be given by the personal data subject or their representative in any form that allows confirmation of the fact of its receipt, unless otherwise established by federal law.

The Operator is obliged to provide proof of obtaining consent of the personal data subject to the processing of their personal data or proof of causes specified in Law No. 152-FZ.

6.2. The personal data subject is entitled to receive information regarding the personal data processing unless otherwise specified by the federal legislation. The personal data subject is entitled to demand that the Operator clarify their personal data, block or destroy them where the personal data are incomplete, outdated, inaccurate, illegally obtained or are not necessary for the declared purpose of processing, as well as implement legal measures to protect their rights.

6.3. Should the personal data subject believe that the Operator is processing their personal data in violation of the requirements of Law No. 152-FZ or otherwise violates their rights and freedoms, the personal data subject is entitled to appeal the actions or inactions of the Operator to the authorized body for the protection of the rights of personal data subject or in court.

6.4. The personal data subject is entitled to protect their rights and legitimate interests, including compensation for damages and / or compensation for moral damage in court.

6.5. The personal data subject is obliged to:

- provide only authenticated personal data;
- inform about the clarification (updating, modification) of personal data.

6.6. Individuals providing false personal data or personal data of another personal data subject without the consent of the latter shall be liable in accordance with the legislation of the Russian Federation.

7. Personal data security

7.1. The security of personal data shall be ensured by the implementation of legal, organizational, technical and software measures necessary and sufficient to meet the requirements of the federal legislation related to personal data protection.

7.2. In order to create unfavorable conditions and obstacles for perpetrators attempting to gain unauthorized access to personal data to acquire, modify, destroy, infect with malware, substitute and commit other unauthorized actions to personal data, the Operator shall implement the following organizational and technical measures during the entire time frame of the Competition:

- appointment of employees responsible for organizing the processing and protection of personal data;
- limitation and regulation of the employees with access to personal data;
- making the employees familiar with the requirements of the federal legislation and the regulatory documentation of the Competition on the processing and protection of personal data;
- ensuring that data storage media are kept and treated in a way that precludes their theft, substitution, unauthorized copying and destruction;

- identification of threats to the personal data security during the processing, formation of threat models based on them;
- validation of the readiness and effectiveness of the information security tools application;
- password protection of access to the personal data information system;
- implementation of anti-virus control, prevention of exposure of the corporate network to malware (software viruses) and software malfunctions;
- detection of intrusions into the Operator's corporate network that violate or create prerequisites for violation of the established requirements for personal data security;
- creation of data backup;
- ensuring the recovery of personal data, modified or destroyed due to unauthorized access thereto;
- educating the employees on the information security tools used in personal data information systems as well as the rules of working with them;
- monitoring user actions, conducting proceedings on violations of personal data security requirements;
- placement of technical means of personal data processing within a secure area;
- maintenance of technical means of security and alarm of premises in a state of constant readiness.

8. Final provisions

8.1. Other rights and obligations of the Operator are determined by the legislation of the Russian Federation in relation to personal data.

8.2. The Operator's liability for violation of the requirements of the legislation of the Russian Federation in relation to processing and protection of personal data shall be determined in accordance with the legislation of the Russian Federation.
